I, Detective Darlene Vita, #98038, the Affiant, state under oath that the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above named person(s), are the following: Your Affiant, Detective Darlene Vita #98038, at the present time, is assigned to the Denver Police Department, Domestic Violence Unit and learned the following information through personal observations, a review of documentation and talking with persons involved in the investigation of this incident. Due to the nature of this incident, on the date of October 30th, 2013, Your Affiant was assigned to conduct Follow-Up Investigation on this case after the listed victim, Ms. DOB 12/1988, contacted the police in regard to an alleged incident of Domestic Violence. On the date of October 30th, 2013, Your Affiant conducted an interview with Ms. investigation. During the interview Ms. stated that on October 28th, 2013, while at her home; 1700 Bassett Street, Apt. Denver, Colorado, her boyfriend, Mr. Semyon Aleksandrovich Varlamov, assaulted her by kicking her in the chest, which knocked her down. While the victim was still on the floor, he then reportedly stomped on her chest with his foot. He then grabbed her by the hair and dragged her out of the bedroom by her hair. While still holding the victim by her hair, Mr. Varlamov pulled the victim's face to the floor and told her in Russian that if this were Russia, he would have beat her more. He then grabbed the victim by her upper arms and shook and pushed her to the floor. On the date of October 30th, 2103, Your Affiant met with Ms. and presented her with an image of Mr. Semyon Aleksandrovich Varlamov; DOB 04/27/1988, which she positively identified as the suspect in this investigation. During the interview Your Affiant also observed bruising on Ms. s left forearm and right hip area. On the date of October 30th, 2013, Detective T. Campbell assisted with this investigation by conducting an According to Ms. she met with Ms. on October 28th, interview with Ms. 2013, at her home; 1700 Bassett Street, Apt. to do her makeup. Ms. noted that during that related to her that due to Mr. Varlamov drinking she was having concerns around him assaulting her. While doing the makeup, Ms. related, she was able to see Ms. upper chest area and did not see any bruises or marks. continued, saying that on October 29th, 2013, she received a telephone call from Ms. Ms. telling her that Mr. Varlamov had assaulted her and asking for help. Ms. related that in an effort to she travelled to 1700 Bassett Street, picked her up and allowed her to stay the night at her assist Ms. house.

On October 30th, 2013, Ms. stated, as Ms. was getting dressed, she observed bruises on Ms.

's left arm and upper left chest area.
